Course description

This seminar explores the genealogy of the concept of populism and the theoretical debates on what it is and how to study it. We will compare historical and current experiences in Latin America, the U.S., and Europe focusing on the relationships between populism, democratization, and authoritarianism.

Course Requirements and Grading Components

Participation 20% First exam on class readings 30% Final paper 50%

For the final paper you must talk to me to select a case study. You will use the theories and concepts that we learned in class and compare your case with experiences that we discussed in the course. Graduate students are expected to write a 15 pages paper, and undergraduates about 10.

Students are expected to attend class, complete the weekly reading assignments prior to each meeting, to participate actively in class discussions and exercises, and to attend the 72 annual conference Feb 29-March 1 2024).
